

# GUIDELINES FOR CONSENT TO USE FOOTPATH FOR CASUAL STREET STALL

Council can consider street stalls under section 139A of the Roads Act for the purposes of fundraising by charitable not for profit organisations and local sporting clubs/groups in nominated commercial areas of the Kiama Council Local Government Area:

## Nominated sites are:

- ☐ Corner of Terralong and Shoalhaven Streets Kiama (58 Terralong Street Kiama)
- ☐ 3 Allowrie Street Jamberoo (outside IGA Supermarket)
- ☐ 113 Fern Street Gerringong (outside Gerringong Pharmacy)
- ☐ 17 -19 Johnson Street Kiama Downs (outside IGA Supermarket Kiama Downs)

## Hours of operation

Stalls are only permitted Thursday/Friday/Saturday between the hours of 9am and 5pm.

Location of stalls must ensure footpath pedestrian accessibility – ie. not within 3 metres of shopfronts in Terralong Street and within 2 metres in other commercial areas.

## Stallholder responsibilities

- Stallholders must comply with Public Health Orders of NSW & Federal Governments.
- Stallholders are responsible for the conduct of their volunteers/employees.
- The area in which the street stall is located must be left in a clean and waste free condition.
- The stallholders must abide by noise regulations and must not use a microphone or loudspeaker.
- Street stalls must not obstruct free passage of pedestrians at any time.
- Appropriate identification of the organisation operating the stall must be displayed in the vicinity of the stall for public view and authorised Council Officers.
- The stallholder must obtain the appropriate approvals regarding the sale of food and beverages if applicable.
- The stallholder must indemnify and hold harmless Council from and against all damages, sums of money, costs, claims and demands which may be sustained or suffered or recovered or made against Council by any person for any injury that person may sustain when using any of the approved nominated sites for holding Street Stalls where that injury arises as a result of the placement of the street stall
- Prior to the issue of consent, the stallholder must provide a current certificate of currency for Public Liability Insurance in the sum of Twenty Million Dollars (\$20,000,000) and ensure Kiama Municipal Council is not The stallholder must maintain the insurance during the term of this consent.

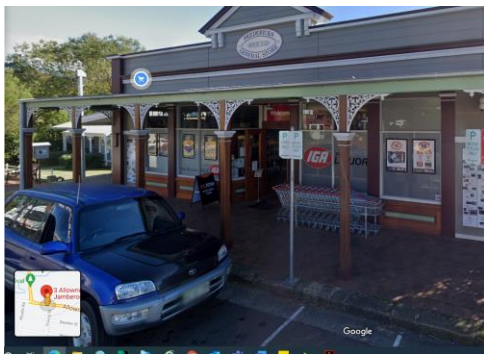
