#### 5.1 Road Closure - Kiama Show 2023

**Resolved** that the Committee recommends that the traffic changes associated with the event on Friday 27 January 2003 and Saturday 28 January 2023 from 5 a.m. to 10 p.m. each day be approved, subject to organisers complying with the following conditions:

- The event organiser complies with the Traffic Management Plan shown in Attachment 1.
- Notification of the closures be given to Police, local emergency services, businesses and affected residents.
- 3. An advertisement be placed in the local media advising of the closure a minimum of seven days prior to the event.
- 4. The Traffic Management Plan be updated to include hostile vehicle mitigation measures and the organiser is notified with this condition.

#### 5.2 Road Closure - Gerringong Christmas Street Parade 2022

- The event organiser complies with the Traffic Management Plan shown in Attachment 1.
- 2. Notification of the closures be given to Police, local emergency services, businesses and affected residents by the event organizer.
- 3. Notification of the closures shall be placed on Council's website a minimum of seven days prior to the event.
- 4. The Traffic Management Plan be updated to include hostile vehicle mitigation measures and the organiser is notified with this condition.
- 5. The event organisers are to consider pedestrian safety measures along Fern Street to keep spectators safe.

#### 6 GENERAL BUSINESS

#### 6.1 Update on flooded and flood damaged roads

SL requested an update on the Swamp Road closure, and the status of the road works on Jamberoo Mountain Road, Wallaby Hill Road, and Foxground Road.

MD advised that Swamp Road was re-opened last week.

Kiama Municipal Council

On Jamberoo Mountain Road, MD advised that Council will very shortly go to tender for a contractor to complete the works. The completion date will depend on the contractors' availability to commence and finish the work.

MD went on to state that Wallaby Hill Road has been load limited until the works are done. It is quite complex and works will continue into the new year.

MD advised Foxground Road has also been load limited and is out on the market for a contractor at the moment. MD is hoping to get tenders back in the next week, and for the works to be completed by Christmas.

#### 6.2 Paid Parking

SL asked about the plan for paid parking, that was resolved at the June and October 2022 Council meeting. MD advised that a Report for Information will be submitted to the November Council meeting, in response to the Question for Future Meeting that was put forth. MD added that we do not have a budget for the investigation of paid parking at present. The report will outline the current status and procedure for these investigations, once Council has a budget for this project.

#### 6.3 Crooked Rivery Winery Festival

AG asked about the safety measures for the bump out at the Crooked River Winery Festival. He has been advised that it can be quite chaotic. There doesn't seem to be any control with vehicles and pedestrians leaving the event, and it is a safety issue. JB advised that this issue also comes up regularly at the Kiama Liquor Accord meetings. MD noted that we need to add increased traffic and pedestrian management for the next event.

#### 6.4 Wombat Crossings

AG asked JB about wombat crossings on Collins Street and Bong Bong Street. JB advised that our Civil Engineer Nathan will discuss this with AG after the meeting. AG added that Council's are forgetting to provide lighting above wombat crossings, which is dangerous.

#### 6.5 School zone projects

SL asked if he could have the timeline of the works for Minnamurra Public School. JB advised that she has been in contact with the school principal, and the works are likely to be undertaken in the Christmas holidays, whilst the school is closed.

The developer of No. 47 Thomson Street, Kiama has constructed two parking bays in the road verge in accordance with development consent 10.2018.225.3. The developer has requested to place Work Zone signage, in accordance with the plan in Attachment 1, at each end of the bays so that only the parking of construction vehicles is permissible during the construction period.

Report of RMS delegated formal items

5.1 Signposted work zone - No. 45 and 47 Thomson Street Kiama (cont)

#### **Background**

Works approved in Development Consent 10.2018.225.3 for a multi-storey residential flat building are currently underway. The developer has constructed off-road parking bays in the road verge adjacent to No.45 & No.47 Thomson Street, Kiama in accordance with the development consent condition below:

The developer may partially construct the works "Angled Parking Design – Plan No. 2562-C00 to C06 (inclusive) prepared by Kiama Municipal Council – dated May 2021" (Plan) to create a construction bay in the footpath verge, where loading/unloading, concrete pump/mixer and crane parking, and the like, can occur.

The developer has requested to place signage, in accordance with the signage plan in Attachment 1 at the end of each constructed bay, so that only construction vehicles can park within the bays during work times. The bays themselves will be used for construction activities, and in this respect, the carriageway will generally remain unencumbered to allow the free flow of traffic in Thomson Street.

The hours of the proposed zone are 7 a.m. to 6 p.m. Weekdays and 8 a.m. to 1p.m. on Saturdays and the duration will be until the works are completed.


