#### 6 GENERAL BUSINESS

#### 6.1 Traffic and Parking Issues in School Zones

JR reported that Council has received a number of complaints relating to traffic and parking issues in school zones, particularly at Kiama Primary School, where traffic in Bong Bong Street is queueing the full length of Thomson Street often to the Terralong Street roundabout. Council's Rangers are being abused by drivers infringed for non-compliance of parking restriction in school zones.

DB advised that while traffic issues around schools are not uncommon, this area has a long history of traffic concerns that are exacerbated by its location, topography, bus zones, off-street staff parking and increases in parent/caregiver traffic and that the Committee and Council have been working with the school over a number of years to improve pedestrian safety and parking in this precinct. AG & JB advised of recent meetings held with the school representatives and Transport for NSW (TfNSW) and to discuss the issues and potential opportunities for grant funding.

The Committee discussed a number of potential options for further investigation including, relocation of the bus zone, increase the number of students using buses, parking restrictions on the southern side of Bong Bong Street, one-way traffic flows in Bong Bong Street, footpath fencing, children's pedestrian crossing in Collins Street, increased staff parking within the school and staggered departure times for the school.

CG stated that the Committee had spoken pre-Covid regarding having the police attend schools at afternoon pickup, with a pop-up information stand to educate and inform parents of the school zone rules. CG advised that this has worked well in other areas in the Illawarra and can be requested to the Community Liaison Police.

#### **Recommended Actions:**

- Kiama Primary School request an exemption through TfNSW from the current 2 km threshold for free bus passes to allow additional students to access bus transport.
- 2. Write to the Education Department regarding the issues surrounding this school and request that they investigate the staggering school finishing times, increasing the on-site parking availability for staff and other improvements to parent pick-up options to alleviate traffic impacts.
- 3. Submit a request to the Police Community Liaison office for attendance at Kiama Primary School with a pop-up information stand.

4. Further funding opportunities be explored with the assistance of TfNSW.

#### 6.2 Traffic Issues at the Charles Avenue and Federal Avenue Intersection

MW advised that the Minnamurra Progress Association have expressed their concerns with the Federal and Charles Avenues intersection, particularly in relation to speeding vehicles, school children and cyclists crossing at this location.

DB advised that Council will investigate this location for possible treatments as deemed necessary and report to the Committee of any proposed changes.

#### 6.3 Loading zone in front of Kiama Visitors Centre

CB queried if the temporary loading zone fronting the Kiama Visitors Centre is to remain given the renovation works are now completed. DB advised that this will be the subject of a future report to the Committee.



# RECOMMENDATION

That approval be given to converting the current temporary Loading Zone fronting the Visitor Information Centre on Blowhole Point Road, Kiama into a permanent Loading Zone.

## REPORT

At the October 2020 Traffic Committee meeting a report was tabled and endorsed for the temporary conversion of an existing No Stopping zone into a Loading Zone at the frontage to the Kiama Visitor Information Centre, to facilitate the refurbishment and expansion of the public amenities at the Centre. As this work has now been completed, it has become apparent that the temporary loading zone has been beneficial for the Centre and associated restaurant in providing a safe and convenient parking area for deliveries, rubbish collection and maintenance contractors, without having any detrimental impacts to parking or traffic flows in the area. In this regard it is proposed that the temporary Loading Zone be made permanent, in accordance with the previously approved signage plans attached. The existing regulatory signage already in place will remain unchanged, however the yellow kerbside no stopping linemarking will need to be removed.


# REPORT

At the April 2021 Traffic Committee meeting the report was endorsed by the Committee for the creation of a timed no parking zone for the 10 parking spaces fronting 48 Manning Street Kiama. This proposed no parking zone was for 5am to 9am Monday to Friday to facilitate garbage collection in this area.

Following representation by the Anglican Church to Public Access prior to the Council meeting, the Council at its meeting on 20 April, resolved to defer the decision on this item for the proposed signage plan pending further clarification. The main objection from the Church was the lack of consultation as they often have programmed events starting at 9am, with volunteers arriving earlier to assist in setups.

To facilitate these concerns, a revised plan has been prepared that proposes to end the no parking zone timeframe 30 minutes earlier at 8.30am. This will allow volunteers to park in this zone from 8.30am before the commencement of the existing 2 hour timed parking restriction commences at 9am.

A signage plan is attached for the Committee's approval.
