## RECOMMENDATION

That the Committee approve a regulatory "Stop" sign and line marking be installed at the intersection of Taylor and Bonaira Streets, Kiama.

## BACKGROUND

Councils has received a number of requests for road safety improvements to the intersection of Taylor and Bonaira Streets, Kiama.

It has been reported that vehicles are failing to stop and that drivers are having difficulties with sight lines at the T-intersection due to parked vehicles on Bonaira Street, blocking reasonable vision for drivers turning out of Taylor Street. It has been reported that this is accentuated due to the topography of the road environment.

It has been requested that one parking space on the northern side of Bonaira Street either side of the Taylor Street intersection be removed to improve sight lines from vehicles parking too close to the intersection

Council have investigated this matter and have found that Bonaira Street currently has an indented parking bay to the east and a parking lane separated by a concrete median to the west of Taylor Street. These existing engineering treatments restrict vehicles parking within 10 metres of this intersection\*, therefore, the removal of additional parking spaces in Bonaira Street is not recommended as it provides minimal road safety benefits.

(\* NSW Road Rules state that you must not park within 10m of an intersection)

Additionally, crash history for the five-year period from 2015 to 2019 show that there was one (1) moderate injury crash in 2017 in Bonaira Street and not at the intersection.


Notwithstanding, it was found the current unsignposted intersection did have some sight-line limitations that would warrant the implementation of a regulatory STOP sign with a STOP LINE which will result in enhanced road safety benefits by improving driver responses to the road environment.

The proposed installation of regulatory signage and line marking will provide the following road safety benefits:

- define priority at the intersection
- improve the drivers line of sight both left and right
- improve compliance with the Road Rules.

On this basis, it is proposed that a regulatory "Stop" sign with line marking be installed at the Taylor and Bonaira Streets intersection.

A plan of the proposal is included attached.

## RECOMMENDATION

That the Committee approve a 'No Stopping' zone to be created on the western side of Johnson Street, Kiama Downs, between Merindah Street and Johnson Lane with the installation of regulatory signage and line marking.

## BACKGROUND

Council has received reports from residents raising concerns with pedestrian and traffic issues in this location.

Johnson Street, Kiama Downs a narrow, two-way street which allows traffic to access the busy shopping strip in both directions. Inspections have shown that when vehicles are parked on both sides of the street it is difficult for vehicles to pass safely. There are currently No Stopping zones adjacent and to the north of the shops in Johnson Street, but none to the south.

Council has been advised that parking issues are exacerbated on busy days, when both traffic and parking is heavy and pedestrian traffic exemplifies the risks to


vulnerable road users accessing the shops. Reports have been received of poor vision of motorists turning into Johnson Street from the south with no passing room for a vehicle turning from Johnson Lane.

Furthermore, It has been reported that during school holidays, vehicles are queued from Johnson Street into Merindah Street awaiting to negotiate the 50 metres where there are vehicles parked on both sides of Street. During these times, residents also report difficulties in exiting their driveways due to the parked vehicles.

Although Transport for NSW crash data shows no reports of injury crashes at this location for the five years from 2014 – 2019, it is proposed that the installation of a "No Stopping" zone with the installation of regulatory signage and line marking on the western side of Johnson Street, between Merindah Street and Johnson Lane will provide the following road safety benefits:

- Improve traffic congestion and pedestrian safety
- Reduce possible of collisions.
- Improve parking compliance with the NSW road rules.

On this basis, it is proposed that "No Stopping" zone with regulatory signage and line marking be installed at this location as per the attached signage and line marking plan.
