Request a User Pays On-Call Kerbside Clean Up service

- The service fee is \$90 and allows up to **100kg or 1m wide x 1m high x 1m deep** of household items (see pg 2 for accepted items). **Additional costs will be sought if load is more than 100kgs.**
- You must book and pay for your service before placing your items out for collection.
- You will be advised of your collection day when you book.
- Place items out by 6.00am on your advised collection day, but no more than 24 hours before.
- Small items must be placed in unwanted boxes or bags.
- Items must be able to be picked up safely by **one person.**
- Place all items neatly, off the road and footpaths.
- Do not place items out that are ineligible for collection. They will NOT be collected.
- Place items out the front of your own property at your normal collection point for your bins
- Do not place items out after the collection has taken place. We will not return.

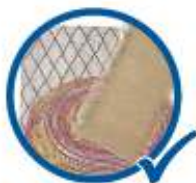
