


# Public Art Design Brief Art & About

Kiama Municipal Council recognises the important role of public art in actively engaging the community, creating a sense of place and enhancing the aesthetic landscape of our town. We are committed to implementing initiatives aimed at cultivating a dynamic and vibrant atmosphere where creativity flourishes. Council is currently pursuing the acquisition of temporary artworks to enrich outdoor bin shelters throughout the town.





**SUMMARY** 

**Commission:** Bin Shelters (Art & About)

**Location:** Various locations including Kiama and Jamberoo

Target: Artists, designers, photographers

Artist fee: \$1,500 (excluding gst)

**Applications close:** 13 May 2024, midnight.

**BACKGROUND** 

The key objective of this initiative is to celebrate art & about, and to provide an innovative way to showcase visual art, where you might least expect. This initiative will also provide opportunities to showcase the work of local artists and designers to enhance the visual

amenity of the town.

**OPPORTUNITY** 

Kiama Council is calling for Expression of Interest from artists, designers or photographers interested in creating digital designs for integration within outdoor bin shelters. The artwork should be unique in design and style; have conceptual links to the surrounding area; and

should reflect the local context, people and place.

Chosen works will be 'in exhibition' for up to six months. There are 3 opportunities

available.

**ABORIGINAL HERITAGE** 

Kiama Municipal Council acknowledges the Traditional Owners of these lands, the Dharawal People, and recognises their continuing connection to the land and waterways. We pay our respect to their Elders past, present and emerging and extend this to all Aboriginal and

Torres Straight Islander People.

**ARTIST BRIEF** 

The selected artist and/or designer will be asked to develop an artwork/s that will be exhibited across 4 different outdoor bin shelters across the town, with a total of eight (8) artworks on exhibition.

KIAMA MUNICIPAL COUNCIL

New work, or existing work that can be adapted, will be considered. Artists will be paid an exhibition fee and may consider a single, centralised work to be repeated across all locations, a series of interlinking pieces, or 8 individual pieces to suit each locale.

The artist/designer may like to respond to the following themes:

- o Land's Edge
  - Beaches, seaside, ocean, headlands, river mouth, harbours, Werri Beach, lighthouse, Black Beach, rock pools, rock platforms, coastal walk, blowholes
- Heritage of Industries
  Cedar-getting, quarrying, farming, shipping, Jamberoo Butter Factory, fishing history
- Aboriginal Significance
  Meeting places, harvest sites, cultural places
- Heritage of settlement:
  Iconic buildings, churches, cemeteries, post office, Saddleback Mountain, Hoddles
  Track
- Unspoilt nature
  Mangroves, waterbirds, casuarina trees, black cockatoos, basalt cliffs, fish, rainforest, Bonaira Reserve, Minnamurra Swamp, escarpment.

The artwork should respond to the below aims:

- Be visually bold and appealing
- Reflect locality, space and place
- o Be visually appealing
- Demonstrate excellence in design and concept
- Not contain business logo, advertising or promotional material, imagery under copyright or imagery that is offensive or obscene or of a sensitive nature.

The designs will be printed and installed as decal stickers. The artist/designer will have final proof before print.

Terralong Street, Kiama and Allowie Street, Jamberoo.

Please note that these location may be subject to change.

# **SPECIFICATIONS**

The selected artist will be required to develop eight (8) digital designs/artworks

The dimensions of the printable area (see above) are 1020mm (wide) X 800mm (high)

Artwork should be supplied as a Vector artwork (eps or vector pdf)

Allow 5-10 mm bleed

If scanning artworks, scan at highest quality (minimum 150 dpi)

Further submission details of final artwork will be given upon success of this EOI.

### **COMMISSION FEE**

Artists/Designers will be paid a commission fee of \$1,500 (ex gst) and is inclusive of outdoor licensing/commissioning fee; research and development of digital artworks; artist statement for interpretive and promotional purposes.

# **APPLICATIONS**

Interested artists are invited to complete an Expression of Interest (EOI) via our website <a href="https://bit.ly/44c6TUQ">https://bit.ly/44c6TUQ</a>

The EOI will include a written description of your artistic approach and style towards the design brief; portfolio images; and artist CV.

Submissions are to be received by midnight Monday 13 May, 2024. No visual concepts or designs are required at this initial stage of application.

The successful applicant will be contracted under a Memorandum of Understanding.

# **SELECTION CRITERIA**

Applications will be accessed based on the following criteria

- Artistic merit and conceptual integrity
- Relevant experience and quality of previous projects

### INTELLECTUAL PROPERY RIGHTS

Copyright in all artworks created and/or exhibited in the course of the contract will remain the property of the Artist. The Artist shall give Council a fixed term, exclusive licence to exhibit the artworks for the purposes, and term, of the project and Council retains the right to document and/or reproduce the work for related non-commercial purposes including publicity and promotion of the project, education and record keeping. Wherever Council reproduces images of the artwork, Council will acknowledge the Artist as the creator of the Artwork and recognise the Moral Rights of the Artist in accordance with the Copyright Act 1968.
