

REQUEST FOR APPROVAL TO CREATE AIR POLLUTION – PILE BURNING OF VEGETATION

- Use this form to obtain permission to make pollution caused by the burning of vegetation.
- Applications to burn piles of vegetation MUST relate to a property performing rural activities.
- This is NOT an application for a Fire Permit. NSW RFS must be notified before commencing works.
- During the Bush Fire Danger Period (1 October to 31 March), you MUST obtain a Fire Permit directly from the NSW RFS
- During the Bush Fire Danger Period (1 October to 31 March), Council Officers will not conduct an inspection although will require a copy of the approved and current NSW RFS Fire Permit.

AN INSPECTION WILL NOT TAKE PLACE UNTIL PILES COMPLY WITH NSW RURAL FIRE SERVICE STANDARDS FOR PILE BURNING - <u>https://www.rfs.nsw.gov.au</u>

What now?

Outside the Bush Fire Danger Period

Your application will be processed and forwarded to our Compliance Team. A Council Officer will contact you within five (5) days to arrange a time for inspection.

When assessing the application Council will take into account the following:

- impact on local air quality and amenity
- feasibility of reuse, recycling or other alternative means of disposal
- quantity of material and length of time that material is likely to burn
- potential for direct smoke impacts on neighbours and surrounding community
- cumulative effects of smoke on regional air quality
- compliance with standards for pile burning.

During the Bush Fire Danger Period

You will need to obtain a copy of an approved and current NSW RFS Fire Permit. This will form part of your application. Without an approved and current NSW RFS Fire Permit, your application will not be approved.

PART 6 - APPLICANT DECLARATION

I declare that:

- 1. There are no prohibited articles included in the piles to be burnt i.e.:
 - tyres
 - coated wire
 - paint/solvent containers and residues
 - timber treated with copper chromium arsenate (CCA) or pentachlorophenol
 - domestic waste.
- 2. During the Bush Fire Danger Period 1 October to 31 March I will obtain a permit from the NSW Rural Fire Service.
- 3. During the months 1 April to 30 September I will notify the NSW Rural Fire Service prior to the commencement of burning any piles.
- 4. I am aware that failure to comply with the conditions of approval may result in a penalty infringement notice being issued.
